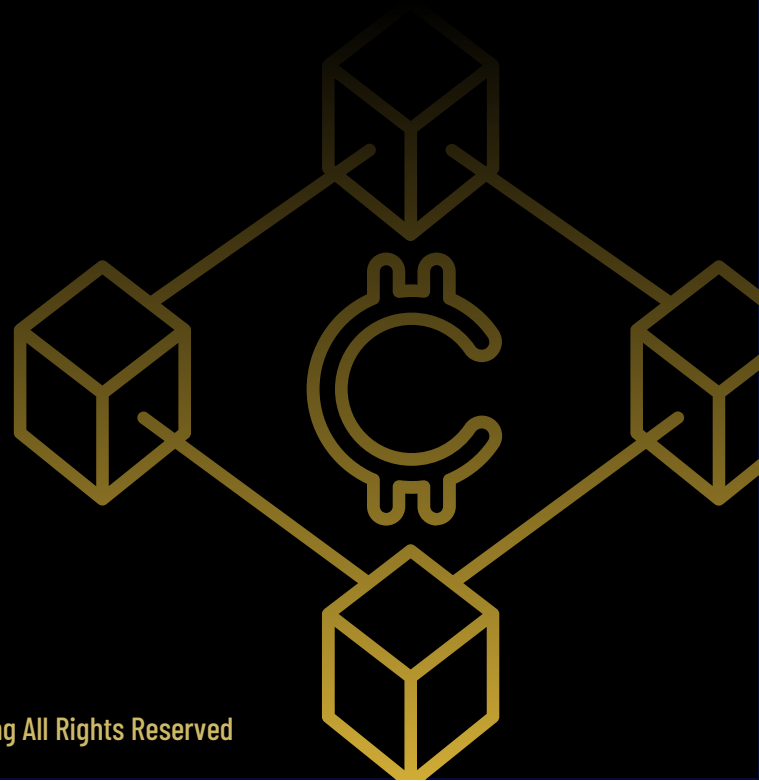
About Us

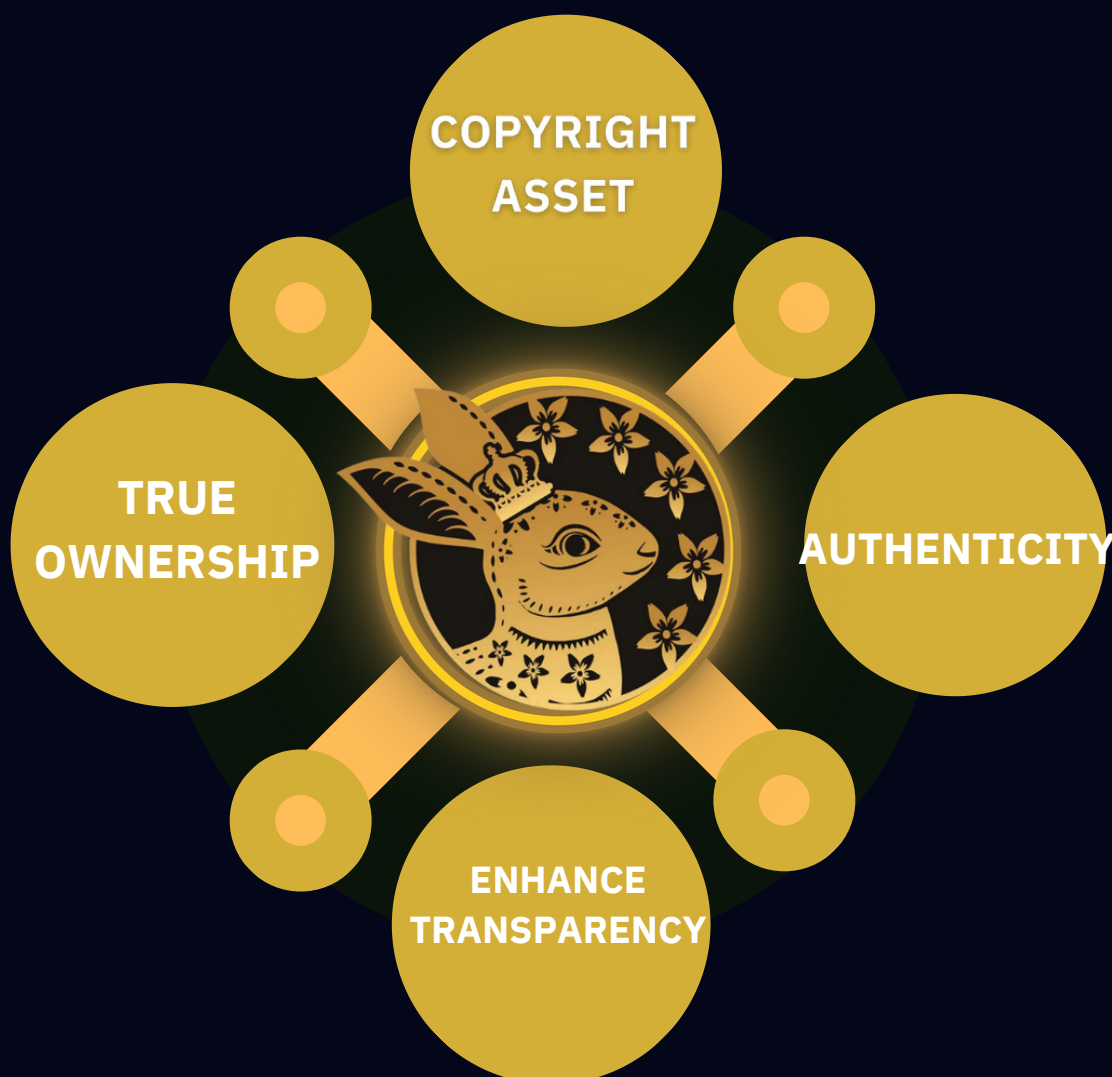


WE ARE TRANSFORMING ENTIRE ECOLOGY!

The network allows participation from community users, ensuring a goes both ways and decentralised blockchain.



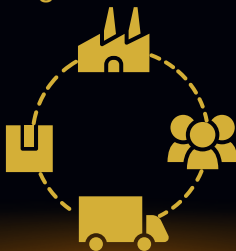
DECENTRALISED GOVERNANCE

Existing smart contracts for Ethereum can be readily transferred to RabbitKing without requiring any additional modifications.

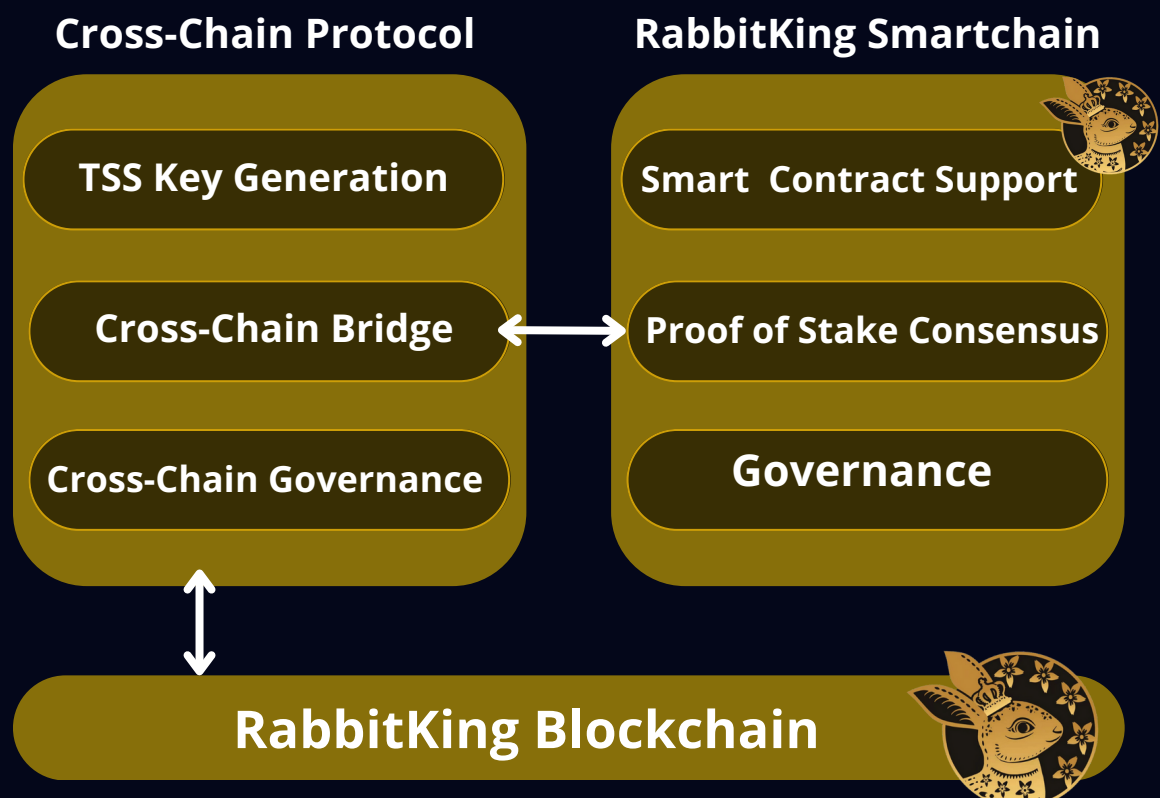


CROSS-CHAIN PROTOCOL



The following are the cross-chain protocol's main characteristics:

- Support for decentralised and safe cross-chains
- A key generation method without trust for threshold signature schemes. Calculation of final signed transactions will be done using generated private shares of the signing key.
- To reduce the danger of a single point of failure, the community and outside partners will also handle the private key sharing (i.e., centralization).
- Organizations using the cross-chain protocol are supported in their ability to vote thanks to the protocol governance mechanism.

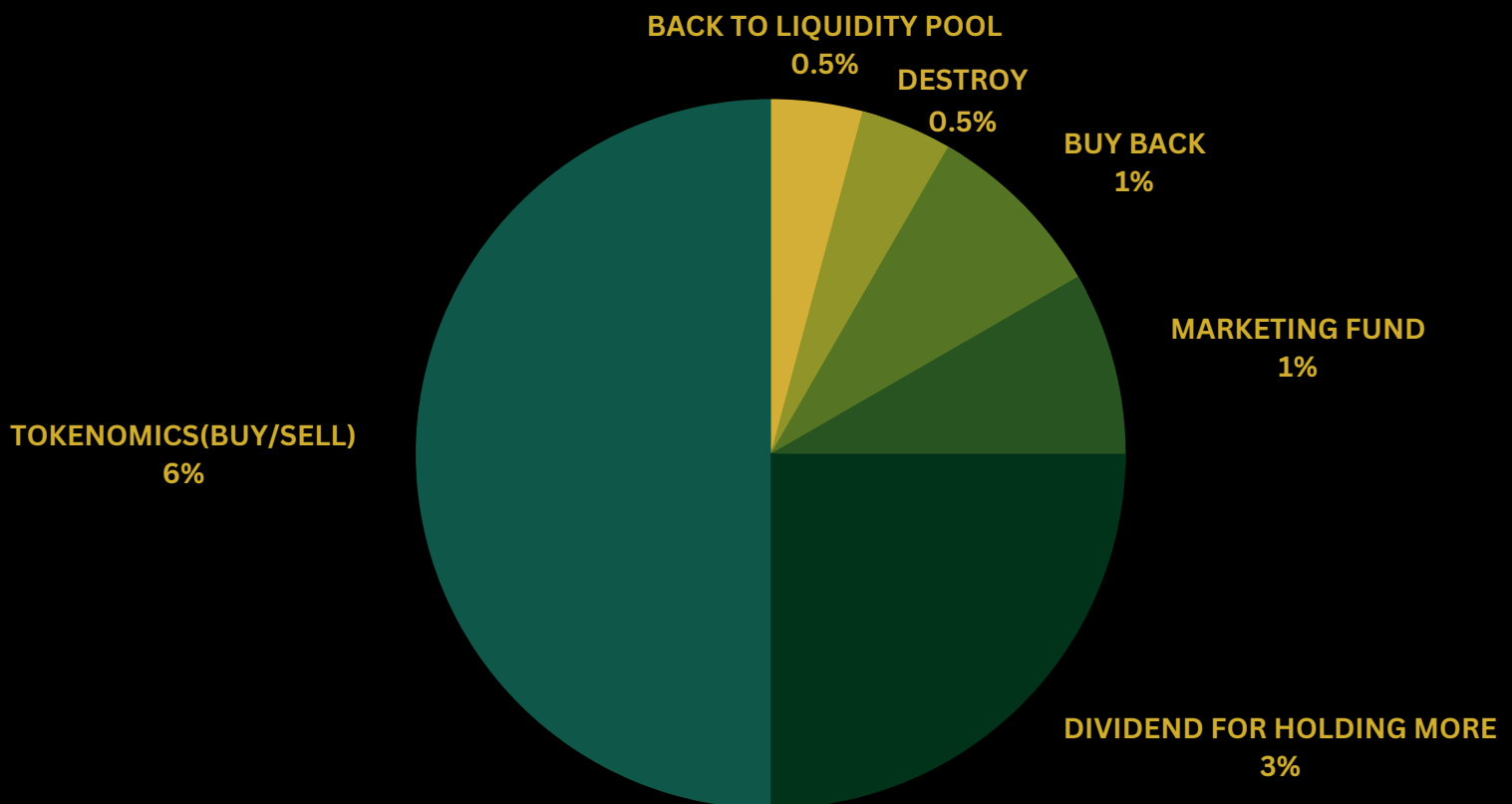
Tokenomics



RabbitKing is a BEP-20 community token built on the Binance Smart Chain, with the transaction tax 6% (buy and sell)

To ensure the RabbitKing price can continue to surge,

- 0.5% of the buy/sell tax is automatically destroyed ,
- 0.5% of the buy/sell tax will contribute to liquidity pool,
- 1% of buy/sell tax will buy back RabbitKing,
- while there is 3% of buy/sell tax will distributed for RabbitKing holder holding more than 30 billion as holding dividend.
